

PRESIDENT'S MESSAGE By Robert Hickey

Since we all find ourselves in uncertain times, it has been my goal to counter this by speaking to as many fellow DDAs as possible. I have spoken to close to 1/3 of our DDA's in the last several months. I am indebted to all those who were willing to spend time talking with me about our common vision for the District Attorney's Office. Many consistent themes have emerged as to the type of leader we should look for and what role the DDAA should have in the selection or election process, should there be a transition. Frankly, I am amazed at the consistency in certain opinions in these conversations; we are united on the key attributes we want from our next leader. Please be assured that myself and others members of the Board have begun positive discussions with the District Attorney, and we will not hesitate to express our positions. Hopefully, we will continue to have your input, whether it is by speaking to me or any other member of the Board. We want to hear from you. Together, we will go forward.

1. One-Time 2 % Monetary Payment – August 5, 2011: The terms of the 2011-2013 contract extension include a one-time 2% monetary payment for all DDAs who have regular service during the first payroll period of the new contract. The payment will appear in your paycheck

- on August 5, 2011. You may want to defer some or all of the 2% monetary payment, to avoid current taxes. The required form, at the end of the newsletter, must be returned by **July 13, 2011**.
- 2. 2011 Hail and Farewell: The 2011 DDAA Hail and Farewell was held on Thursday, May 19, 2011 at the La Jolla Beach and Tennis Club. Thank you to DDA Michael Runyon for doing a great job as emcee and "Farewelling" Chief Deputy District Attorney Jeff Dusek, Judge Richard Monroy, Judge Michael Groch, Marty Martins, and Steve Anear.
- 3. State Bar Board of Governors Election (District 9) Vote for Heather Rosing: You should have received a California State Bar ballot for the District 9 Board of Governors election. District 9 covers San Diego, Imperial, Riverside and San Bernardino counties. Voting closes on June 30, 2011. The DDAA Board has endorsed and urges you to vote for Heather Rosing.
- 4. CYAC Battle of the Badges IX Saturday, June 18, 2011: The Barona Band of Mission Indians, the Community Youth Athletic Center (CYAC), and the National Latino Peace Officers Association are holding the 9th annual "Battle of the Badges" charity boxing event on Saturday, June 18, 2011 at the Barona Valley Ranch Resort and Casino. - 5. 2011 SDCERA Retirement Board Election Doug Rose: SDCERA members have chosen three experienced trustees to represent them on the Board of Retirement. A total of 12 candidates ran in the May 17 election the largest candidate field in recent years. Collectively, winners have more than 45 years of board experience. DDA Doug Rose won re-election to a fourth term representing active members. E. F. "Skip" Murphy, a retired Sheriff's Department captain and former trustee, won his bid to represent retired members. He won the seat currently held by longtime trustee James Feeley, who ran unopposed as the alternate trustee representing retired members. SDCERA Board terms begin on July 1, 2011.
- 6. 2011 DAI/DDA Baker to Vegas Team: Congratulations to Team Captain / DAI John Gunderson and the 2011 DAI/DDA Baker to Vegas Team for placing 14th in their division at the Annual Baker to Vegas Race on April 16-17, 2011. The race is a 120 mile relay race from Baker, California to Las Vegas, Nevada, with teams comprised of active and retired members of law enforcement agencies from all over the world. The DDAA supports our Baker to Vegas Team. Start training now for next year's race!
- 7. Attack on Public Employee Pensions UPDATE: Although Orange County's attack on public employees pensions appears to be dead, various initiatives and legislative "fixes" are still being discussed which could have a dramatic effect on pensions for both current and future public employees. There is some question about the constitutionality of changing pensions for current public employees. One bill currently in the legislature would eliminate compensation for sick leave upon retirement. We will continue to monitor the issues and keep you advised.

- REQUESTS FOR ONETIME 457 CONTRIBUTION CHANGES MUST BE MADE THROUGH THE COUNTY OF SAN DIEGO DEFERRED COMPENSATION DEPARTMENT, AND SHOULD NOT BE MADE THROUGH THE NATIONWIDE CALL CENTER OR WEBSITE. Contribution change requests submitted to Nationwide will be effective indefinitely unless a subsequent contribution change request is submitted. The subsequent contribution change request will not be effective until the first full paycheck of the month following the date it is received.
- The new contribution rate must be a whole dollar amount **determined by the employee**. Certain deductions such as the employee share of Old Age, Survivors, and Disability Insurance (OASDI), Medicare (MED), Retirement Contributions, Healthcare Premiums, Union Dues, and Supplemental Life Insurance Premiums are taken out prior to Deferred Compensation Deductions. As a general rule the new contribution rate should not exceed 70% of your projected gross earnings but calculations can vary based on your personal situation. If the new contribution rate exceeds the dollar amount remaining after these deductions, then no money will be deducted for deferred compensation.
- If the employee does not enter an old contribution dollar amount on this form, the contributions will be \$0.00 for all subsequent paychecks until the employee makes a contribution change through Nationwide. The subsequent contribution change request will not be effective until the first full paycheck of the month following the date it is received.
