The entire DDAA Board also thanks District Attorney Bonnie Dumanis for her support of our need for ongoing raises and our need for help with educational debt carried by so many of our younger prosecutors. Her assistance was very important.

I want to thank the DDAA Board, Salary Team, Table Team and all of you for your support and unity over the past year as we prepared for negotiations and the past five months during negotiations. After about twelve years on the Board, I have never seen a Board with so much unity and integrity. You can all be proud of your representatives.

Over the past five years, we have been on the receiving end of an economic crisis for which we had no responsibility and over which we had no control. Happily, the tide is turning. This contract will not solve all of our problems, but it definitely gets us moving in the right direction.

On his first day in Vista, he reported for duty and was given a motion to work on. Around lunchtime, Chris was quietly typing away on his computer, when he heard a choking sound. He listened for 3 or 4 seconds and became concerned. The choking sounds continued, along with what sounded like knocking on a desktop.



Chris instinctively ran to the sound and saw someone attempting the Heimlich maneuver on Peggy Gray, whom he had not yet met. Peggy was bent over her desk in distress. To Chris, it looked like more strength would help so he got behind her and delivered a mighty thrust upward and inward. But nothing changed. So he did it again, and again no change.

Finally on the third thrust, some food was dislodged and Peggy was able to take a slight breath, although something was still wrong. Paramedics arrived, taking Peggy to the hospital to be checked out. All afternoon, North County was abuzz with talk of the amazing new intern. Chris said he has never been trained in performing the Heimlich, and he just acted on instinct.

Observers say he absolutely saved Peggy's life.

The next morning, our grateful Peggy was back at work, calling Chris her Superman. And the rest of us are predicting great results in the courtroom for our hero who showed such commitment, composure and selflessness on his very first day at work.

F. Dale Marriott: 12/27/1930 - 05/03/2013

SAN DIEGO -- While recently visiting family, F. Dale Marriott suffered a heart attack and later died on May 3, 2013 in an Ontario, CA hospital from resulting complications. Dale was born on December 27, 1930 in Sioux

City, Iowa and lived there until joining the Army during the Korean War in 1951. He served in the Free Territory of Trieste, Italy where he met his wife, Lois, while she was visiting her sister and brother-in-law, also stationed in Trieste. They would have celebrated their 60th wedding anniversary on August 17, 2013. Dale graduated from the University of Iowa with a BS in Commerce, with Distinction. He worked for Salinas Public Schools as an Accountant and later as Purchasing Agent from 1958-1966 when he, Lois and their five children moved to San Diego for Dale to pursue law school. During his last year of law school, he was employed as a consultant by San Diego State University to equip the then new Malcolm Love Library and to supervise the transfer of more than 750,000 volumes across campus into the new building. He graduated from the University of San Diego, School of Law, Cum Laude in 1969. After working in private practice and for the courts, he joined the San Diego County District Attorney's Office in 1973. He worked Appellate Complaints/ Extradition, Superior Court, Major Violators Unit, and was the Assistant Chief in both El Cajon and South Bay. He retired in 1994, and is remembered by his colleagues as a great mentor and true gentleman who went out of his way to help others. Those who worked for Dale knew him as a source of sage advice, good humor, endless patience and genuine caring. After retirement, Dale contributed countless hours of volunteer service to the Zoological Society of San Diego. Dale and Lois loved to travel and explored many cities in the United States where they especially loved visiting the local zoos. They also became world travelers visiting countries in Russia, Europe, China, Africa and the Americas. Dale equally enjoyed attending cultural events at theatres and museums throughout Southern California. He especially developed a penchant for gourmet cooking in his later years though he always enjoyed a good restaurant meal with friends and a glass of fine wine. Dale was preceded in death by his mother, Margaret Ann (Schroeder); father, William; sister, Mary Lou Lonergan; and brothers, Kenneth John and Charles Montgomery. He is survived by his wife, Lois, and children, Valerie, Cynthia, David, Peter and Michelle; fourteen grandchildren; four great-grandchildren, and many nieces and nephews. He will forever be missed by all who called him friend and no less by his devoted toy poodle, Gigi. Contributions in memory of Dale may be made to the American Cancer Society or the Zoological Society of San Diego. A memorial service was held at Sacred Heart Catholic Church in Coronado on May 23, 2013.

1. Call to Order: Vice-President Walter called the meeting to order at 5:17 p.m. at the SDCBA Bar Center, 401 West "A" Street, 11th Floor.

2. Association Comment: None.

3. Treasurer's Report:

The Board discussed the costs of the recent contract negotiations, about \$17,500, which included advice from our labor attorney, accountant services, ads in the U-T San Diego, final contract meeting, and contract voting website.

If any member desires to see an itemized list of our spending and savings, it is available by contacting Treasurer Cari Philpott.

4. President's Report: Vice-President Walter said thanks had been expressed on behalf of the DDAA Board to the District Attorney for her assistance with the recent contract negotiations with the County. The call for nominations for this year's DDAA Awards will go out soon, so DDAs are encouraged to start thinking about nominations and who is deserving of recognition this year. The Board discussed sending an e-invite out to the membership for the DDAA Awards Banquet in order to save money and "Go Green." Traditional mail invitations would still go out to dignitaries and others outside of the District Attorney's Office. The Board of Supervisors will have two readings of our contract by the end of June in order to ratify the agreement. DDAA Treasurer Cari Philpott will be re-calculating DDAA dues for all members, as their will be a slight increase in dues because of the increase in base pay in the new contract.

- 5. Request to Support the San Diego County Mock Trial Competition: Director Koerber addressed the Board about the San Diego County Mock Trial Competition. The District Attorney's Office, notably retired DDA Kim-Thoa Hoang and DDA Chryseis Starros were instrumental in bring the Mock Trial Competition to San Diego County. Now, the San Diego County Bar Association and the Superior Court oversee the program. The Mock Trial Competition is a statewide academic competition in which high school students compete at the county, state and national level. This year, participation included over 500 students in San Diego County and over 8,000 students statewide. The trial itself is a simulation of a criminal case, in which students portray each of the principals in the cast of courtroom characters. Student teams study a hypothetical case, conduct legal research, and receive guidance from volunteer attorneys in courtroom procedures and trial preparation. Students participate as lawyers, witnesses, court clerks, and bailiffs, thus acquiring a working knowledge of our The Mock Trial Competition encourages young people to iudicial system. develop their analytical abilities and communication skills while gaining increased self-confidence. Many current DDAs assist with the Mock Trial Competition, acting as attorney coaches for the students, volunteer scorers, and judges. Director Koerber asked the DDAA Board to consider financial support of the program so that it may be as inclusive as possible for students in San Diego County. Director Koerber will ask retired Judge Linda Quinn, co-chair of the San Diego County Mock Trial Competition, to address the DDAA Board at a future meeting. Matter deferred.
- **6.** Request to Sponsor a DDAA Float for the Pride Parade: The Board voted to authorize \$750 to sponsor the DDAA float in the Pride Parade on July 13, 2013. (Motion: Philpott; Second: Koerber. Vote: Unanimous.)
- 7. DDA I and II Rotations: Director Kirvin updated the Board on DDAA participation in preparations for the upcoming DDA transfers. Chief Deputy District Attorney David Greenberg contacted Director Kirvin for assistance of the DDAA with the rotational process. Director Kirvin assembled information from the DDA Classes of 2009, 2011, and 2012 as to their experience and past and present assignments. The DDAs were forthcoming with the information, and were encouraged to discuss career development with their Division Chief and Assistant Chief. Rotation of the newer DDAs also impacts rotations of more senior prosecutors, in order to meet the needs of the office. After good reviews from the last rotations where a similar procedure was used, all are hopeful as to the current rotational process.
- 8. DDAA Awards Planning and Consideration of an Award Recognizing the late Judge George "Woody" Clarke: The Board discussed a request to consider an award to honor the late Judge George "Woody" Clarke, who served more than two decades in our office before his appointment to the bench. Director Koerber suggested re-naming the Award for Judicial Excellence in his honor. Director Daly suggested creation of a new DDAA award, specifically

recognizing excellence by a DDA in a particular subject matter area, such as "Woody's" with DNA evidence. The Board voted to create a new award named after "Woody" for DDA excellence in a particular subject matter area. (Motion: Daly. Second: Williams. Vote: Unanimous.) The Board also discussed possible revision or elimination of particular DDAA Awards. However, no action was taken in that regard.

- 9. PAC Report and Consultant's Report: Consultant Wainio updated the Board on the recent elections for San Diego City Council District 4 and California State Assembly District 80. Mr. Wainio also discussed possible nominees for awards from San Diegans Against Crime at the upcoming DDAA Awards Banquet in September.
- **10. Executive Session:** The Board met in Executive Session. Not reported.
- 11. Next DDAA Board Meeting: The next DDAA Board meeting will be on Tuesday, July 2, 2013 at 5 p.m. in the SDCBA Building at 401 West "A" Street, 11th Floor. All DDAA members are welcome to attend.
